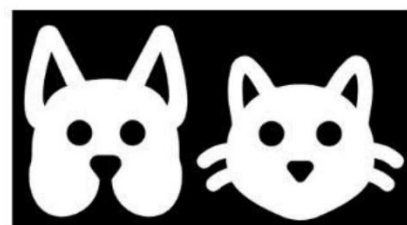

Only **one cat per show** can be entered by each Junior Exhibitor

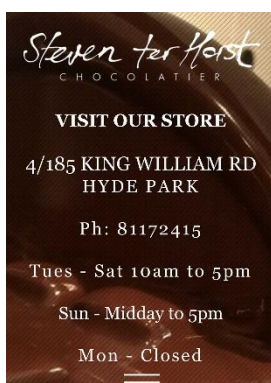
